#### 136 Charges on Consolidated Fund.

[<sup>F1</sup> There shall be charged on and paid out of the Consolidated Fund of the United Kingdom]—

- (b) the pensions payable under section one hundred and sixteen to persons who have held office as judges;

### 137 Payments out of voted moneys.

There shall be defrayed out of moneys [<sup>F5</sup> provided by the Parliament of the United Kingdom all expenses] (other than those provided for by section one hundred and thirty-six) incurred in carrying this Act into effect, and in particular (but without prejudice to the generality of the foregoing words)—

- (a) the remuneration and expenses of persons acting as deputy judges under section one hundred and seven, and the expenses of judges under sub-section (3) of section one hundred and six;
