## *General*

### **58 Interpretation**

#### (1) In this Act—

“pre-school children” means—

- (a) children who are under school age and have not commenced attendance  
at a primary school (other than a nursery class in such a school); and
- (b) children who have attained school age but have not commenced  
attendance at such a school; and

“school [<sup>F9</sup> improvement] plan” means [<sup>F10</sup> an improvement] plan prepared under  
section 6(1)(a) of this Act for a school.

#### (2) Any expression used in this Act and in the 1980 Act has the same meaning in this Act as in that Act.
