5. The Act does not apply to the River Tweed or the Upper Esk (section 71(3), (4)). The repeals and revocations made by section 70(2) and Part 2 of schedule 4 do not affect the enactments in question so far as applying to the River Tweed or the Upper Esk. Provisions in enactments being consolidated which apply only to the Tweed or the Upper Esk (identified as “Tweed provision” or “Esk provision” in column 4 of the Table of Destinations) are not re-enacted in the Act.
