## 1967 CHAPTER 8

An Act to make provision for financial aid towards expenditure in relation to fishing vessels and for purposes connected therewith. [23rd May 1967]

### 1 Grants in relation to fishing vessels.

- (1) Subject to the provisions of this Act, the Ministry of Agriculture may, in accordance with a scheme made by that Ministry with the approval of the Ministry of Finance, make out of moneys provided by Parliament to any person carrying on or proposing to carry on a business in the fishing industry in Northern Ireland a grant towards so much of the expenditure incurred by that person—
- (a) in providing a fishing vessel; or
  - (b) in providing an engine for a fishing vessel; or
  - (c) in improving a sea fishing vessel;

for use for the purposes of that business as may be approved by the Ministry of Agriculture in pursuance of the scheme.

- (2) [<sup>F2</sup> Subject to subsection (2A),] no grant shall be made in pursuance of a scheme under this Act in respect of expenditure incurred in providing any vessel, engine, part, equipment or apparatus which appears to the Ministry of Agriculture to be second-hand.

[<sup>F3</sup> (2A) A grant may be made in pursuance of a scheme under this Act in respect of that part of the expenditure (approved as mentioned in subsection (1)), incurred in providing a second-hand vessel, which is attributable to any liability to repay—

- (a) a grant under this Act or any other statutory provision; or

(b) a grant under the law of any other part of the United Kingdom; in respect of the vessel or any engine, part, equipment or apparatus therein.]

(3) A scheme<sup>F4</sup> made under this Act—

(a) may provide for—

- (i) repayment of grant in specified circumstances;
- (ii) the imposition of penalties in respect of contraventions of provisions of the scheme;

## 2 Interpretation and short title.

(1) In this Act—

“fishing vessel” means a vessel which is provided for use in catching fish and is primarily so used;

“improving” in relation to a fishing vessel includes the acquisition, installation, modification, renewal or replacement of any part of such a vessel or of any relevant equipment required for or installed or used on such a vessel.

(2) This Act may be cited as the Fishing Vessels (Grants) Act (Northern Ireland) 1967.
