INTERNATIONAL TRAVEL

94 International travel

- (1) The Scottish Ministers may by regulations make provision for the purposes of or in connection with—
- (a) giving effect to—
 - (i) the International Health Regulations;
 - (ii) any other international agreements [^{F1}or arrangements] relating to the spread of infectious disease or contamination [^{F2}(including any recommendations issued under such agreements or arrangements)], so far as they have effect in or as regards Scotland;
 - (b) protecting public health from risks arising from vehicles—
 - (i) arriving in Scotland;
 - (ii) leaving Scotland.
- (2) Regulations under subsection (1) may, in particular make provision—
- (a) for persons to be—
 - (i) medically examined;
 - (ii) quarantined;
 - (iii) detained;
 - (b) for persons to be required to provide information or answer questions (including information or questions relating to health);
 - (c) for vehicles to be detained;
 - (d) for prohibitions or restrictions on—
 - (i) the entry and departure of persons or things;
 - (ii) the arrival and leaving of vehicles;
 - (e) for things to be—
 - (i) inspected;
 - (ii) tested;
 - (iii) detained;
