**STRATEGIC INVESTMENT**

**The Strategic Investment and Regeneration of Sites (Maze/Long Kesh Development Corporation) Order (Northern Ireland) 2011**

*Laid before the Assembly in draft*

*Made - - - - 1st June 2011*

*Coming into operation 1st October 2010*

The Office of the First Minister and deputy First Minister makes the following Order in exercise of the powers conferred on it by Article 15(1) and 15(3) of, and paragraph 2(1)(b) of Schedule 1 to, the Strategic Investment and Regeneration of Sites (Northern Ireland) Order 2003<sup>(1)</sup> and of every other power enabling it in that behalf.

**Citation and commencement**

1. This Order may be cited as the Strategic Investment and Regeneration of Sites (Maze/Long Kesh Development Corporation) Order (Northern Ireland) 2011 and shall come into operation on 1st October 2010.

**Interpretation**

2. In this Order—

“the 2003 Order” means the Strategic Investment and Regeneration of Sites (Northern Ireland) Order 2003;

“the Corporation” means the Maze/Long Kesh Development Corporation established under Article 3;

“the Maze/Long Kesh site” means the area of land described in the Schedule.

**Establishment of Development Corporation**

3. There is hereby established a development corporation within the meaning of Article 15(1) of the 2003 Order, to be known as the Maze/Long Kesh Development Corporation.

**Relevant Site**

4. The Corporation shall exercise its functions in relation to the relevant site known as the Maze/ Long Kesh site.

**Membership of the Corporation**

5. In addition to the chairman, the corporation shall consist of 10 other members.

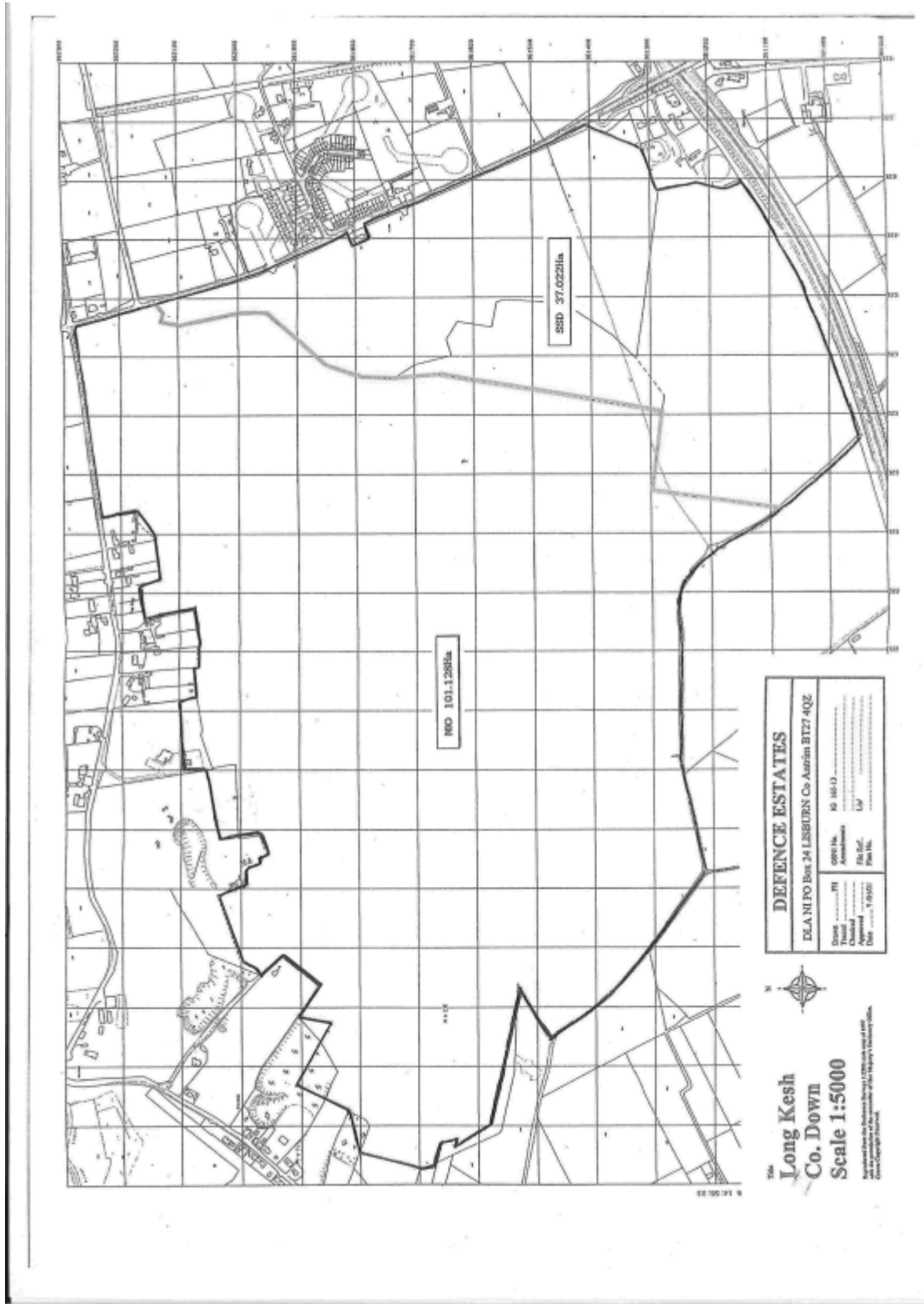
