# ROAD TRAFFIC AND VEHICLES

The Taxis (2008 Act) (Commencement No. 2) Order (Northern Ireland) 2012

*Made - - - - 7th August 2012* 

The Department of the Environment makes the following Order in exercise of the powers conferred by section 59 of the Taxis Act (Northern Ireland) 2008(1).

## Citation and interpretation

- 1.—(1) This Order may be cited as the Taxis (2008 Act) (Commencement No.2) Order (Northern Ireland) 2012.
  - (2) In this Order "the Act" means the Taxis Act (Northern Ireland) 2008.

### **Appointed Day**

- **2.**—(1) The day appointed for the coming into operation of the provisions of the Act specified in Part 1 of the Schedule for the purpose only of making regulations, is 8<sup>th</sup> August 2012.
- (2) The day appointed for the coming into operation of the provisions of the Act specified in Part 2 of the Schedule is, 1<sup>st</sup> September 2012.
