Citation and interpretation

1.—(1) This Order may be cited as the Local Government (2014 Act) (Commencement No. 4) Order (Northern Ireland) 2015.

(2) In this Order "the Act" means the Local Government Act (Northern Ireland) 2014.

(3) In this Order any reference to a numbered section is a reference to a section of the Act.

4. The day appointed for the coming into operation of the provision of the Act listed in Schedule 3 is 1st April 2017.
