SUPPLEMENTARY BENEFITS, ETC.

Claims and payments

- 1 (1) Section 5 above shall have effect in relation to the benefits specified in sub-paragraph (2) below as it has effect in relation to the benefits to which it applies by virtue of subsection (2).
- (2) The benefits mentioned in sub-paragraph (1) above are benefits under—
- (a) the former National Insurance Acts;
 - (b) the former Industrial Injuries Acts;
 - (c) the ^{M1}National Assistance Act (Northern Ireland) 1948;
 - (d) the ^{M2}Supplementary Benefits &c. Act (Northern Ireland) 1966;

- “the former Industrial Injuries Acts” means the ^{M7}Industrial Injuries Act (Northern Ireland) 1946 and the ^{M8}Industrial Injuries Act (Northern Ireland) 1966.
