^{F2}46 Power to prohibit publication of certain matter in newspapers.

- (1) In relation to any proceedings in any court . . . ^{F3}, the court may direct that—
- (a) no newspaper report of the proceedings shall reveal the name, address, or school, or include any particulars calculated to lead to the identification, of [^{F4}a person under the age of seventeen years] concerned in the proceedings, either as being the person [^{F5}by or against] or in respect of whom the proceedings are taken, or as being a witness therein;
 - (b) no picture shall be published in any newspaper as being or including a picture of [^{F4}a person under the age of seventeen years] so concerned in the proceedings as aforesaid;

except in so far (if at all) as may be permitted by the direction of the court.

- (2) Any person who publishes any matter in contravention of any such direction shall on summary conviction be liable in respect of each offence to a fine not exceeding [^{F6}level 4 on the standard scale].
