1879 CHAPTER 44 42 and 43 Vict

An Act to make provision in regard to the office of Lord Clerk Register of Scotland, and for other purposes. [11th August 1879]

2 Status, &c. of Lord Clerk Register.

The Lord Clerk Register shall continue to be one of the officers of state of Scotland, and shall have the same status and precedence as heretofore; but save as herein provided, no rights, authorities, privileges, or duties shall be attached to the office of Lord Clerk Register.

3 Lord Clerk Register to be Keeper of the Signet.

The Lord Clerk Register shall as heretofore be Keeper of the Signet, and shall continue to have all the rights, authorities, privileges, and duties belonging to the office of such keeper, including the right of appointing a deputy keeper and the officers in the Signet Office.
