1898 CHAPTER 44 61 and 62 Vict

An Act to amend the Law with regard to the provision for the payment of certain Expenses under the Merchant Shipping Act 1894, and with regard to the levying of Light Dues.
[12th August 1898]

Such fees shall be paid in respect of the registration, transfer (including transmission), and mortgage of British ships as the Board of Trade, with the consent of the Treasury, determine . . . F9 and all such fees shall be paid into the Exchequer. Provided that fees shall not be payable under this section in respect of vessels [F10 not exceeding ten tons gross register employed solely in fishing].
