#### SOCIAL SECURITY

#### TERMS AND CONDITIONS OF EMPLOYMENT

The Social Security Benefits Up-rating Order 1999

*Made - - - - 4th February 1999* 

Coming into force in accordance with article 1(2)

Whereas, the Secretary of State for Social Security having made a review under section 150(1) of the Social Security Administration Act 1992(1), a draft of the following Order was laid before Parliament in accordance with the provisions of sections 150(2) and 190(1)(a) of that Act and approved by resolution of each House of Parliament;

Now, therefore, the Secretary of State for Social Security, with the consent of the Treasury(2), in exercise of the powers conferred by sections 150 and 189(1), (3) and (4) of the Social Security Administration Act 1992, and of all other powers enabling him in that behalf, hereby makes the following Order:

#### PART I

#### INTRODUCTION

#### Citation and commencement

- 1.—(1) This Order may be cited as the Social Security Benefits Up-rating Order 1999.
- (2) Subject to paragraph (3) of this article, this Order shall come into force for the purposes of—
  - (a) articles 1, 2, 6, 22 and 27, on 1st April 1999;
  - (b) article 8, in so far as it relates to a particular beneficiary, on the first day of the first benefit week to commence for that beneficiary on or after 1st April 1999, and for the purpose of this sub-paragraph, "benefit week" has the same meaning as in the Computation of Earnings Regulations;
  - (c) articles 3 to 5, 7, 11, 12 and 13, on 12th April 1999;

- (d) article 9, on 6th April 1999;
- (e) article 10, on 4th April 1999;
- (f) articles 14 and 15, on 15th April 1999;
- (g) articles 16, 17 and 26, on 13th April 1999;
- (h) articles 18, 19 and 20, in so far as they relate to a particular beneficiary, on the first day of the first benefit week to commence for that beneficiary on or after 12th April 1999, and for the purpose of this sub-paragraph, "benefit week" has the same meaning as in the Income Support Regulations;
- (i) article 21, in relation to a case where rent is payable at intervals of a week or any multiple thereof, on 5th April 1999, and in relation to any other case, on 1st April 1999;
- (j) articles 23, 24 and 25, in so far as they relate to a particular beneficiary, on the first day of the first benefit week to commence for that beneficiary on or after 12th April 1999, and for the purpose of this sub-paragraph, "benefit week" has the same meaning as in the Jobseeker's Allowance Regulations.
- (3) The increases made—
  - (a) in the sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act; and
  - (b) by article 23(c) of this Order in so far as it is relevant for the purposes referred to in article 6(11) of this Order,

shall take effect for each case on the date specified in relation to that case in article 6 of this Order.

#### Interpretation

- 2. In this Order, unless the context otherwise requires—
  - "the Computation of Earnings Regulations" means the Social Security Benefit (Computation of Earnings) Regulations 1996(3);
  - "the Contributions and Benefits Act" means the Social Security Contributions and Benefits Act 1992(4);
  - "the Council Tax Benefit Regulations" means the Council Tax Benefit (General) Regulations 1992(5);
  - "the Disability Working Allowance Regulations" means the Disability Working Allowance (General) Regulations 1991(6);
  - "the Family Credit Regulations" means the Family Credit (General) Regulations 1987(7);
  - "the Housing Benefit Regulations" means the Housing Benefit (General) Regulations 1987(8);
  - "the Income Support Regulations" means the Income Support (General) Regulations 1987(9);

#### PART II

#### SOCIAL SECURITY BENEFITS AND PENSIONS

#### Increase in rates or amounts of certain benefits under the Contributions and Benefits Act

- **3.**—(1) The sums specified in paragraph (2) below shall be increased from and including the respective dates specified in article 6 below so as to have effect as set out in Schedule 1 to this Order.
- (2) The sums mentioned in paragraph (1) above are the sums specified in Parts I, III, IV and V of Schedule 4 to the Contributions and Benefits Act (contributory periodical benefits, non-contributory periodical benefits, increases for dependants and rates of industrial injuries benefit), except in Part III the sum specified for age addition to a pension of any category, and otherwise under section 79 of that Act.

### Increase in rates or amounts of certain pensions or allowances under the Contributions and Benefits Act

- **4.**—(1) The sums specified in paragraphs (2), (3) and (4) below shall be increased from and including the respective dates specified in article 6 below.
- (2) The sums falling to be calculated under paragraph 13(4) of Schedule 7 to the Contributions and Benefits Act (calculation of weekly rate of a beneficiary's retirement allowance) shall be increased by 3.2 per cent. of their amount apart from this Order.
- (3) In section 44(4) of the Contributions and Benefits Act(12) (basic pension in a Category A retirement pension)—
  - (a) for the sum of £62.05 there shall be substituted the sum of £64.05; and
  - (b) for the sum of £64.70 there shall be substituted the sum of £66.75.
  - (4) It is hereby directed(13) that the sums which are—
    - (a) the additional pensions in long-term benefits calculated by reference to any final relevant year earlier than the tax year 1998–99;
    - (b) the increases in the rates of retirement pensions under Schedule 5 to the Contributions and Benefits Act(14) (increase of pension where entitlement is deferred); and
    - (c) payable to a pensioner as part of his Category A or Category B retirement pension by virtue of an order made under section 126A of the Social Security Act 1975(15), section 63 of the Social Security Act 1986(16) or section 150(1)(e) of the Social Security Administration Act 1992(17),

shall in each case be increased by 3.2 per cent. of their amount apart from this Order.

#### Increase in rates or amounts of certain benefits under the Pension Schemes Act

- **5.**—(1) It is hereby directed(**18**) that the sums specified in paragraph (2) below shall be increased from and including the respective dates specified in article 6 below.
- (2) Sums which are payable by virtue of section 15(1) of the Pension Schemes Act (which provides for increases in a person's guaranteed minimum pension if payment of his occupational pension is postponed after he attains pensionable age) to a person who is also entitled to a Category A or Category B retirement pension (including sums payable by virtue of section 17(2) and (3) of that Act), shall be increased by—
  - (a) 3.2 per cent. of their amount apart from this Order where the increase under section 15(1) is attributable to earnings factors for the tax year 1987–88 and earlier tax years(19); and
  - (b) 0.2 per cent. of their amount apart from this Order where the increase under section 15(1) is attributable to earnings factors for the tax years 1988–89 to 1996–97 inclusive.

#### Dates on which sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act are increased by this Order

- **6.**—(1) Paragraphs (2) to (9) of this article, which are subject to the provisions of paragraphs (10) and (11) below, specify the date on which the increases made by this Order in the sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act, shall take effect for each case.
- (2) Subject to paragraph (3) below, the increases in the sums mentioned in articles 3, 4 and 11 of this Order for Category A and Category B retirement pension and graduated retirement benefit together with, where appropriate, increases for dependants, shall take effect on 12th April 1999.
- (3) In the case of a person over pensionable age whose entitlement to a Category A retirement pension is deferred and for whom the rate of short-term incapacity benefit falls to be calculated in accordance with section 30B(3) of the Contributions and Benefits Act(20), the increases in the sums mentioned in articles 3, 4 and 11 of this Order for Category A and Category B retirement pension and graduated retirement benefit together with, where appropriate, increases for dependants, shall take effect on 15th April 1999.
- (4) The increases in the sums mentioned in articles 4(4)(c) and 5(2) shall take effect on 12th April 1999.
- (5) The increases in the sums specified for the rate of maternity allowance, widowed mother's allowance, widow's pension, Category C and Category D retirement pension, child's special allowance(21), attendance allowance, invalid care allowance (except in a case where the Secretary of State has made arrangements for it to be paid on a Wednesday), together with, in each case where appropriate, increases for dependants, and guardian's allowance shall in all cases take effect on 12th April 1999.

- (6) The increases in the sums specified for the rate of invalid care allowance in a case where the Secretary of State has made arrangements for it to be paid on a Wednesday together with, where appropriate, increases for dependants, disablement benefit together with increases of disablement pension, maximum disablement gratuity under paragraph 9(2) of Schedule 7 to the Contributions and Benefits Act, industrial death benefit by way of widow's and widower's pension and allowance in respect of children together with, where appropriate, increases for dependants, and the maximum of the aggregate of weekly benefit payable for successive accidents, under section 107(1) of the Contributions and Benefits Act, shall in all cases take effect on 14th April 1999.
- (7) In any case where a person's weekly rate of Category A or Category B retirement pension falls to be increased under the provisions of section 47(1) or 48C(2) of the Contributions and Benefits Act(22) by reference to the weekly rate of invalidity allowance or age addition to long-term incapacity benefit to which he was previously entitled, the increase in such sum shall take effect on 12th April 1999.
- (8) The increases in the sums specified for the rate of incapacity benefit and severe disablement allowance (together with, where appropriate, increases for dependants) shall take effect in all cases on 15th April 1999.
- (9) The increases in the sums falling to be calculated in accordance with paragraph 13(4) of Schedule 7 to the Contributions and Benefits Act (retirement allowance) shall take effect on 14th April 1999.
- (10) In the case of a person who is subject to the provisions of regulations made under section 73(1)(b) of the Social Security Administration Act 1992(23) (adjustment of benefit for persons undergoing medical or other treatment as an in-patient in a hospital) the increase in the sum mentioned in article 4(3)(b) of this Order shall take effect in that case on the day on which the increase in the benefit payable to him apart from those regulations takes effect.
- (11) The increases in the sums specified in articles 3 and 23(c) of this Order, in so far as those sums are relevant for the purposes of establishing whether the rate of any benefit is not to be increased in respect of an adult dependant because the earnings of the dependant exceed a specified amount(24), shall take effect—
  - (a) except in a case where sub-paragraph (b) below applies, on the first day of the first benefit week to commence for the beneficiary on or after 12th April 1999;
  - (b) in a case where regulation 7(b) of the Computation of Earnings Regulations (date on which earnings are treated as paid) applies, on the first day of the first benefit week to commence for the beneficiary on or after 1st April 1999,

and for the purposes of this paragraph "benefit week" has the same meaning as in regulation 2(1) of the Computation of Earnings Regulations.

### Increase in rates of certain workmen's compensation and industrial diseases benefits in respect of employment before 5th July 1948

7. In Schedule 8 to the Contributions and Benefits Act the sum of £38.70 referred to in paragraph 2(6)(c) (maximum weekly rate of lesser incapacity allowance supplementing workmen's compensation) and paragraph 6(2)(b) (industrial diseases benefit schemes: weekly rate of allowance payable where disablement is not total) shall be increased; and from and including 14th April 1999

for that sum in paragraph 2(6)(c), and from and including 15th April 1999 for that sum in paragraph 6(2)(b), there shall be substituted the sum of £39.95.

#### **Earnings Limits**

- **8.** In section 80(4) of the Contributions and Benefits Act (earnings limits in respect of child dependency increases)—
  - (a) for the sum of £140.00 in both places where it occurs there shall be substituted the sum of £145.00; and
  - (b) for the sum of £18.00 there shall be substituted the sum of £19.00.

#### **Statutory Sick Pay**

**9.** In section 157(1) of the Contributions and Benefits Act (rate of payment of statutory sick pay) for the sum of £57.70 there shall be substituted the sum of £59.55.

#### **Statutory Maternity Pay**

**10.** In regulation 6 of the Statutory Maternity Pay (General) Regulations 1986(**25**) (lower rate of statutory maternity pay) for the sum of £57.70 there shall be substituted the sum of £59.55.

#### Increase in rate of graduated retirement benefit

- 11.—(1) In the National Insurance Act 1965(26) the sum of 8.40 pence referred to in section 36(1) (graduated retirement benefit) shall be increased by 3.2 per cent.; and from and including 12th April 1998 the reference in that provision to that sum shall have effect as a reference to 8.67 pence.
- (2) The sums which are the increases of graduated retirement benefit under Schedule 2 to the Social Security (Graduated Retirement Benefit) (No. 2) Regulations 1978(27) (increases for deferred retirement) shall be increased by 3.2 per cent. of their amount apart from this Order.
- (3) The sums which are the additions under section 37(1) of the National Insurance Act 1965 (additions for widows and widowers) shall be increased by 3.2 per cent. of their amount apart from this Order.

#### **Increase in rates of Disability Living Allowance**

- **12.** In regulation 4 of the Social Security (Disability Living Allowance) Regulations 1991(28) (rate of benefit)—
  - (a) in paragraph (1)(a), for the sum of £51.30 there shall be substituted the sum of £52.95;
  - (b) in paragraph (1)(b), for the sum of £34.30 there shall be substituted the sum of £35.40;
  - (c) in paragraph (1)(c), for the sum of £13.60 there shall be substituted the sum of £14.05;
  - (d) in paragraph (2)(a), for the sum of £35.85 there shall be substituted the sum of £37.00; and
  - (e) in paragraph (2)(b), for the sum of £13.60 there shall be substituted the sum of £14.05.

#### Sums specified for child benefit

- **13.** In regulation 2(1) of the Child Benefit and Social Security (Fixing and Adjustment of Rates) Regulations 1976(**29**) (weekly rates of child benefit)—
  - (a) in sub-paragraph (a)(i), for the sum of £11.45 there shall be substituted the sum of £14.40;
  - (b) in sub-paragraph (a)(ii), the sum specified is £17.10; and
  - (c) in sub-paragraph (b), for the sum of £9.30 there shall be substituted the sum of £9.60.

#### Increase in rates of age addition to long-term incapacity benefit

- 14. In the Social Security (Incapacity Benefit) Regulations 1994(30), in regulation 10(2)—
  - (a) in sub-paragraph (a), for the sum of £13.60 there shall be substituted the sum of £14.05; and
  - (b) in sub-paragraph (b), for the sum of £6.80 there shall be substituted the sum of £7.05.

#### Increase in rates of transitional invalidity allowance in long-term incapacity benefit cases

- **15.** In the Social Security (Incapacity Benefit) (Transitional) Regulations 1995(**31**), in regulation 18(2)—
  - (a) in sub-paragraph (a), for the sum of £13.60 there shall be substituted the sum of £14.05;
  - (b) in sub-paragraph (b), for the sum of £8.60 there shall be substituted the sum of £8.90; and
  - (c) in sub-paragraph (c), for the sum of £4.30 there shall be substituted the sum of £4.45.

#### PART III

# FAMILY CREDIT, DISABILITY WORKING ALLOWANCE, INCOME SUPPORT, HOUSING BENEFIT AND COUNCIL TAX BENEFIT

#### **Family Credit**

- **16.** In the Family Credit Regulations—
  - (a) in regulation 46(4) (determination of appropriate maximum family credit) the capital sum prescribed is £3,000;
  - (b) in regulation 46(4), (5) and (6), the amount specified for the credit in respect of a child or young person is NIL;
  - (c) in regulation 47(1)(32) (applicable amount), for the sum of £79.00 there shall be substituted the sum of £80.65; and
  - (d) in Schedule 4 (determination of maximum family credit), the sums prescribed shall be as set out in Schedule 2 to this Order.

#### **Disability Working Allowance**

17. In the Disability Working Allowance Regulations—

- (a) in regulation 51(4) (determination of appropriate maximum disability working allowance) the capital sum prescribed is £3,000;
- (b) in regulation 51(4), (5) and (6), the amount specified for the allowance in respect of a child or young person is NIL;
- (c) in regulation 52(1)(33) (applicable amount)—
  - (i) in sub-paragraph (a), for the sum of £59.25 there shall be substituted the sum of £60.50:
  - (ii) in sub-paragraph (b), for the sum of £79.00 there shall be substituted the sum of £80.65; and
- (d) in Schedule 5 (determination of appropriate maximum disability working allowance) the sums prescribed shall be as set out in Schedule 3 to this Order.

#### **Applicable amounts for Income Support**

- **18.**—(1) The sums relevant to the calculation of an applicable amount as specified in the Income Support Regulations shall be the sums set out in the following provisions of this article and Schedules 4 to 8 to this Order; and for this purpose references in this article to a numbered regulation or Schedule are, unless the context otherwise requires, references to a regulation of, or a Schedule to, the Income Support Regulations bearing that number.
- (2) In regulations 17(1)(b), 18(1)(c), 21(1) and 71(1)(a)(ii), (b)(ii) and (iii), (c)(ii) and (d)(i), in paragraph 14(a) of Part III of Schedule 2, and in paragraph 1(2) of Part I of Schedule 4, the sum specified is in each case £3,000.
- (3) The sums specified in Part I of Schedule 2 (applicable amounts: personal allowances) shall be as set out in Schedule 4 to this Order.
  - (4) In paragraph 3 of Part II of Schedule 2(34) (applicable amounts: family premium)—
    - (a) in sub-paragraph (1)(a) the sum specified is £15.75; and
    - (b) in sub-paragraph (1)(b) for the sum of £11.05 there shall be substituted the sum of £13.90.
- (5) The sums specified in Part IV of Schedule 2 (applicable amounts: weekly amounts of premiums) shall be as set out in Schedule 5 to this Order.
  - (6) In paragraph 18 of Schedule 3(35) (housing costs: non-dependant deductions)—
    - (a) in sub-paragraph (1)(a) for the sum of £45.00 there shall be substituted the sum of £46.35;
    - (b) in sub-paragraph (1)(b) for the sum of £7.00 there shall be substituted the sum of £7.20;
    - (c) in sub-paragraph (2)(a) for the sum of £78.00 there shall be substituted the sum of £80.00;
    - (d) in sub-paragraph (2)(b) for the sum of
      - (i) £78.00 there shall be substituted the sum of £80.00,
      - (ii) £116.00 there shall be substituted the sum of £118.00, and



#### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order is made as a consequence of a review under section 150 of the Social Security Administration Act 1992 ("the Administration Act") and includes details of the sums mentioned in that section.

Part I of the Order relates to the citation, commencement and interpretation.

Part II of the Order relates to non-income related benefits other than jobseeker's allowance.

Article 3 and Schedule 1 alter the benefits and increases of benefits (except the over 80 age addition) specified in Parts I, III, IV and V of Schedule 4 to the Social Security Contributions and Benefits Act 1992 ("the Contributions and Benefits Act").

Article 4 increases the rates and amounts of certain pensions and allowances under the Contributions and Benefits Act.

Article 5 increases the sums payable as part of a Category A or Category B retirement pension under sections 15(1) and 17(2) and (3) of the Pension Schemes Act 1993 ("the Pension Schemes Act") on account of increases in guaranteed minimum pensions.

Article 6 specifies the dates from which the sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act are altered.

Article 7 increases the rates of certain workmen's compensation and industrial injuries benefits in respect of employment before 5th July 1948.

Article 8 specifies earnings limits for child dependency increases.

Article 9 increases the weekly rate of statutory sick pay.

Article 10 increases the lower rate of statutory maternity pay.

Article 11 increases the rate of graduated retirement benefit.

Article 12 increases the rates of disability living allowance.

Article 13 increases the weekly rates of child benefit, except the rate payable in respect of an only, elder or eldest child of a lone parent.

Article 14 increases the weekly rates of age addition to long-term incapacity benefit.

Article 15 increases the weekly rates of transitional invalidity allowance in long-term incapacity benefit cases.

Part III of the Order relates to family credit, disability working allowance, income support, housing benefit and council tax benefit.

Article 16 and Schedule 2 specify the applicable amount for family credit and the amount of the credits for an adult, child or young person which determines a family's maximum family credit.

Article 17 and Schedule 3 specify the applicable amount for disability working allowance and the amount of allowance for an adult, child or young person which determines the appropriate maximum disability working allowance.

Article 18 states the amount of sums relevant to the applicable amount for the purposes of income support. Article 18(3) and Schedule 4 set out the personal allowances; article 18(4) and (5) and Schedule 5 set out the premiums; article 18(7) and Schedule 6 set out the amounts relevant to

beneficiaries in residential care and nursing homes; article 18(8) and Schedule 7 set out the amounts relevant to special cases; and article 18(9) and Schedule 8 set out other miscellaneous amounts.

Article 19 provides for the percentage increase of sums payable by way of special transitional additions to income support.

Article 20 states the sum by which any income support of a person involved in a trade dispute is reduced.

Article 21 states the amount of the sums relevant for the purposes of housing benefit. Article 21(6) and Schedule 9 set out the personal allowances and article 21(8) and Schedule 10 set out the premiums.

Article 22 states the amount of the sums relevant for the purposes of council tax benefit. Article 22(5) and Schedule 11 set out the personal allowances and article 22(6) and (7) and Schedule 12 set out the premiums.

Part IV of the Order relates to jobseeker's allowance.

Article 23 increases the age-related amounts of contribution-based jobseeker's allowance.

Article 24 states the amount of sums relevant to the applicable amount for the purposes of income-based jobseeker's allowance. Article 24(3) and Schedule 13 set out the personal allowances; article 24(4) and (5) and Schedule 14 set out the premiums; article 24(7) and Schedule 15 set out the amounts relevant to beneficiaries in residential care and nursing homes; article 24(8) and Schedule 16 set out the amounts relevant to special cases; and article 24(9) and Schedule 17 set out other miscellaneous amounts.

Article 25 states the sum by which any jobseeker's allowance of a person involved in a trade dispute is reduced.

Part V of the Order relates to transitional provisions and revocation.

Article 26 contains transitional provisions relating to family credit and disability working allowance.

Article 27 revokes the Social Security Benefits Up-rating Order 1998 (S.I.1998/470).

In accordance with section 150(8) of the Administration Act, a copy of the report of the Government Actuary (Cm. 4199) giving his opinion on the likely effect on the National Insurance Fund of the making of this Order was laid before Parliament with the draft Order.

An assessment of the cost to business of applying the statutory sick pay and statutory maternity pay provisions of this Order has been placed in the library of both Houses of Parliament.
