The Plant Protection Products (Amendment) (No.2) Regulations 2006

Made - - - - 8th November 2006

Laid before Parliament 13th November 2006

Coming into force in accordance with regulation 1(3)

The Secretary of State for Environment, Food and Rural Affairs and the National Assembly for Wales are designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to the common agricultural policy of the European Community.

Acting jointly (the National Assembly for Wales acting in relation to Wales only), in exercise of the powers conferred upon them by that section, they make the following Regulations:

Citation, interpretation and commencement

- **1.**—(1) These Regulations may be cited as the Plant Protection Products (Amendment) (No.2) Regulations 2006.
- (2) In these Regulations "the principal Regulations" means the Plant Protection Products Regulations 2005(3).
 - (3) These Regulations come into force—
 - (a) for the purposes of regulation 2(3), on 1st February 2007;
 - (b) for all other purposes on 6th December 2006.

Amendment to the principal Regulations

- **2.**—(1) The principal Regulations are amended as follows.
- (2) At the end of Schedule 1 (instruments amending Council Directive 91/414), insert in the respective columns indicated the entry set out in Part 1 of the Schedule to these Regulations.
- (3) At the end of Schedule 1, insert in the respective columns indicated the entries set out in Part 2 of the Schedule to these Regulations.

Schedule 1 to the principal Regulations, which sets out the instruments that amend that Directive, is amended by the insertion of the entries set out in the two Parts of the Schedule to these Regulations.
