EXPLANATORY NOTE

(This note is not part of the Order)

This Order, which comes in to force on 1st May 2007, substitutes a new Schedule to the Courts Boards Areas Order 2004 (made under section 4(2) of the Courts Act 2003). The new Schedule amends the description of courts boards areas in England and Wales to reflect changes in some of the boundaries, which have been altered in order to align with administrative areas of Her Majesty's Courts Service. This Order also revokes the Courts Boards Areas (Amendment) Order 2004.
