REPRESENTATION OF THE PEOPLE

The Electoral Administration Act 2006 (Commencement No.7) Order 2008

Made - - - - 13th May 2008

The Secretary of State, in exercise of the powers conferred by section 77(2) and (3) of the Electoral Administration Act 2006(1), makes the following Order:

Citation and interpretation

- **1.**—(1) This Order may be cited as the Electoral Administration Act 2006 (Commencement No.7) Order 2008.
 - (2) In this Order "the Act" means the Electoral Administration Act 2006.

Commencement of provisions of the Electoral Administration Act 2006

- **2.**—(1) The provisions of the Act listed in article 3 shall come into force on the day after the day on which this Order is made in so far as they extend to Northern Ireland.
- (2) The provisions of the Act listed in article 4 shall come into force on 1st July 2008 in so far as they extend to Northern Ireland.
 - (3) The provisions of the Act listed in article 5 shall come into force on 1st July 2008.

 - (v) section 66 (Details to appear on referendum and election material);
 - (w) section 68 (Funding of services and expenses of returning officers);
 - (x) section 73(1) and (2) (Abolition of common law incapacity: mental state);
 - (y) section 74 (Miscellaneous amendments and repeals) for the purposes of the provisions specified in paragraph (z) (iv) to (vi) and (aa);
