COMMISSION DECISION

of 30 July 1973

amending Commission Decision of 20 Juné 1973 authorizing the Republic of France to apply special intervention measures for rye

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 120/67/ EEC (¹) of 13 June 1967 establishing a common market for cereals, as last amended by Regulation (EEC) No 1346/73 (²), and in particular Article 8, second paragraph thereof;

Having regard to Council Regulation No 174/67/ EEC (3) of 27 June 1967 on special intervention measures for cereals, as amended by Regulation (EEC) No 445/68 (4), and in particular Article 1 thereof;

Whereas the Republic of France was authorized, by the Commission Decision of 20 June 1973, to apply special measures for rye; these measures consist of granting a lump-sum allowance of 2.75 units of account per metric ton in respect of a total quantity not exceeding 2 000 metric tons to stockholders whose stocks of rye of bread-making quality comply with the conditions laid down in Commission Regulation (EEC) No 1554/73 (5) on the conditions for granting compensatory allowances for soft wheat, rye of bread-making quality and maize in stock at the end of the season 1972/73;

Whereas in the light of the most recent information it has been established that the needs of the French milling-trade in rye of bread-making quality, to ensure normal operations during the transition from one marketing season to the next, are much more important than was initially realized; whereas, therefore, in accordance with the request of the French Republic, addressed to the Commission on 27 June 1973, the total quantity which is not to be exceeded for which the lump-sum allowance of 2.75 units of account may be paid should be brought from 2 000 metric tons to 10 000 metric tons;

Whereas the measures provided for in this Decision are in accordance with the Opinion of the Management Committee for Cereals;

HAS ADOPTED THIS DECISION:

Article 1

In Article 1 second paragraph of the Commission Decision of 20 June 1973 authorizing the Republic of France to apply special intervention measures for rye, the figure '2 000' is replaced by that of '10 000'.

Article 2

This Decision is addressed to the Republic of France.
