## **COMMISSION DECISION**

## of 28 November 1974

amending the Commission Decision of 22 December 1972 authorizing the Federal Republic of Germany to sell butter at a reduced price in the form of concentrated butter

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 804/ 68 (1) of 27 June 1968 on the common organization of the market in milk and milk products, as last amended by Regulation (EEC) No 662/74 (2), and in particular Article 6 (7) thereof;

Having regard to Council Regulation (EEC) No 985/ 68 (3) of 15 July 1968 laying down general rules for intervention on the market in butter and cream, as last amended by Regulation (EEC) No 2714/72 (4), and in particular Article 7a thereof;

Whereas, pursuant to Commission Regulation (EEC) No 349/73 (5) of 31 January 1973 on the sale at reduced prices of intervention butter for direct consumption as concentrated butter, as last amended by Regulation (EEC) No 2570/74 (6), which replaced Regulation (EEC) No 2561/72 (7), the Commission Decision of 22 December 1972 (8) authorizing the Federal Republic of Germany to sell butter at a reduced price in the form of concentrated butter, as last amended by the Decision of 2 September 1974 (9), fixed the quantity of butter to be processed by that Member State, having regard to available outlets as determined on the basis of previous action, at 10 000 metric tons;

Whereas this quantity may not be sufficient to cover requirements until the end of the current milk marketing year; whereas it is accordingly appropriate to increase it to 11 500 metric tons;

Whereas the measures provided for in this Decision are in accordance with the Opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS DECISION:

## Article 1

The quantity '10 000 metric tons' specified in Article 1 of the Decision of 22 December 1972 is replaced by '11 500 metric tons'.

## Article 2

This Decision is addressed to the Federal Republic of Germany.
