COMMISSION DECISION

of 28 July 1976

extending for six months Decision 71/314/ECSC of 27 July 1971 authorizing specialization Agreements covering the manufacture of rolled-steel products and Agreements for the setting up of an agency to allocate orders for merchant steel bars and wire rod between Eisenwerk-Gesellschaft Maximilianshütte mbH, Klöckner-Werke AG and Stahlwerke Peine-Salzgitter AG

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Coal and Steel Community, and in particular Article 65 thereof,

Having regard to Decision 71/314/ECSC of 27 July 1971 authorizing specialization Agreements covering the manufacture of rolled-steel products and Agreements for the setting up of an agency to allocate orders for merchant steel bars and wire rod between Eisenwerk-Gesellschaft Maximilianshütte mbH, Klöckner-Werke AG and Stahlwerke Peine-Salzgitter AG ⁽¹⁾,

Having regard to Decision 76/354/ECSC of 13 February 1976 extending Decision 71/314/ECSC until 30 June 1976 ⁽²⁾,

Having regard to the application from the undertakings concerned dated 29 June 1976,

Whereas :

1. By Decision 71/314/ECSC of 27 July 1971, the Commission gave an authorization under Article 65 of the Treaty to the following steel undertakings :

Eisenwerk-Gesellschaft Maximilianshütte mbH, Sulzbach-Rosenberg ;

Klöckner-Werke AG, Duisburg ;

Stahlwerke Peine-Salzgitter AG, Peine,

for specialization Agreements covering the manufacture of rolled-steel products and Agreements for the setting up of an agency to allocate orders for merchant steel bars and wire rod. This Decision expired on 31 December 1975.

2. By its Decision 76/354/ECSC of 13 February 1976 the Commission extended the application of the first Decision until 30 June 1976 to enable the undertakings concerned to complete their negotiations with the object of consolidating through new Agreements the results achieved with the specialization Agreements which had been authorized.

3. Those concerned submitted to the Commission on 29 June 1976 a contract for cooperation and specialization Agreements and asked for an extension of the existing Agreements for the period necessary to enable the new Agreements to be examined under Article 65 of the Treaty.

4. The grounds for the extension Decision of 13 February 1976 remain valid and are accordingly applicable to the present Decision.

5. In the circumstances an extension for a period of six months of Decision 71/314/ECSC can be authorized,

HAS ADOPTED THIS DECISION :

Article 1

Decision 71/314/ECSC of 27 July 1971 authorizing specialization Agreements covering the manufacture of rolled-steel products and Agreements for the setting up of an agency to allocate orders for merchant steel bars and wire rod between Eisenwerk-Gesellschaft Maximilianshütte mbH, Klöckner-Werke AG and Stahlwerke Peine-Salzgitter AG is extended until 31 December 1976.
