THE COUNCIL OF THE EUROPEAN COMMUNITIES

Having regard to the Treaty establishing the European Economic Community, and in particular
Article 238 thereof,

Having regard to the recommendation from the Commission,

Having regard to the assent of the European Parliament⁽¹⁾,

Whereas the Additional Protocol to the Cooperation Agreement between the European
Economic Community and the Syrian Arab Republic⁽²⁾, signed at Brussels on 18 January 1977,
should be approved.

HAS DECIDED AS FOLLOWS:

Article 1

The Additional Protocol to the Cooperation Agreement between the European
Economic Community and the Syrian Arab Republic is hereby approved on behalf of
the Community.

The text of the Protocol is attached to this Decision.

Article 2

The President of the Council shall give the notification provided for in Article 5 of the
Protocol⁽³⁾.

Article 3

This Decision shall take effect on the day following its publication in the *Official Journal
of the European Communities*.
