On 9 September 2011 the competent authorities of the Netherlands informed the Commission about practical problems in several slaughterhouses with the timely implementation of the new methods and asked to postpone the application until 2 January 2012.
- (2) Implementing Decision 2011/303/EU should therefore be amended accordingly.
- (3) The measures provided for in this Decision are in accordance with the opinion of the Management Committee for the Common Organisation of the Agricultural Markets,
