REGULATION (EEC) No 2509/70 OF THE COMMISSION

of 11 December 1970

amending Regulation (EEC) No 193/70 establishing the procedure for giving effect to measures to promote the marketing of oranges and mandarins in the Community

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 2511/69¹ of 9 December 1969 laying down special measures for improving the production and marketing of Community citrus fruit, and in particular Article 7 thereof;

Whereas Commission Regulation (EEC) No 193/70² of 2 February 1970 establishing the procedure for giving effect to measures to promote the marketing of oranges and mandarins in the Community was originally concerned with oranges of varieties other than Biondo commune; whereas the scope of the Regulation was subsequently extended to oranges of the Biondo variety by Commission Regulation (EEC) No 344/70³ of 25 February 1970; whereas the reasons for this extension are still valid and there are grounds for extending the provisions of Regulation (EEC) No 193/70 to oranges of the variety in question for the present marketing year;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Fruit and Vegetables.

HAS ADOPTED THIS REGULATION:

Article 1

The following shall be substituted for the second subparagraph of Article 2 of Regulation (EEC) No 193/70:

'Oranges of the Biondo commune variety, of the "Extra" Class and Class I, may also be the subject of contracts for the 1969/70 marketing year.'

Article 2

The following shall be substituted for Article 3a of Regulation (EEC) No 193/70:

Article 3a

For oranges of the Biondo commune variety the dates and conditions provided for in Article 3 (1) shall be fixed as follows:

- the closing date for concluding contracts shall be 1 January 1971;
- the period of the contract shall be at least sixty days;
- the quantities to which they relate shall be at least 60 metric tons net.'

Article 3

For the 1970/71 marketing year 1 January 1971 shall be substituted for 1 December 1970 in column 2 of Annex 1 to Regulation (EEC) No 193/70.

Article 4

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.
