**REGULATION (EEC) No 705/71 OF THE COMMISSION
of 31 March 1971**

amending Regulation (EEC) No 1027/68 on the determination of prices of calves and adult bovine animals on representative Community markets

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 805/68¹ of 27 June 1968 on the common organisation of the market in beef and veal, as last amended by Regulation (EEC) No 1253/70² and in particular Article 10 (5) thereof;

Whereas Commission Regulation (EEC) No 1027/68³ of 22 July 1968 on the determination of prices of calves and adult bovine animals on representative Community markets laid down the representative markets of each Member State for the various qualities of calves, adult bovine animals or the meat of these animals, as the case may be;

Whereas, in order to clarify market definitions in France for adult bovine animals and to take account, in Germany, of certain structural alterations in the market for adult bovine animals and calves, the list of representative markets for these two countries appearing in Annex II to Regulation (EEC) No 1027/68 should be amended;

Whereas under Article 1 of Council Regulation (EEC) No 541/70⁴ of 20 March 1970 on agriculture in the Grand Duchy of Luxembourg the provisions of the first subparagraph of Article 1 (1) of the Protocol on the Grand Duchy of Luxembourg are no longer

applicable; whereas the provisions of Regulation (EEC) No 1027/68 relating thereto now serve no purpose and should therefore be repealed;

Whereas the coefficients expressing the relative number of bovine animals in each Member State, used in calculating the price on representative Community markets, should be brought up to date;

Whereas the measures laid down in this Regulation are in accordance with the Opinion of the Management Committee for Beef and Veal;

HAS ADOPTED THIS REGULATION:

Article 1

Annexes I and II to this Regulation shall be substituted for Annexes I and II to Regulation (EEC) No 1027/68;

Article 2

Article 1 second paragraph and Article 5 (3) of Regulation (EEC) No 1027/68 are hereby repealed.

Article 3

This Regulation shall enter into force on 1 April 1971. It shall first apply for the calculation of the levies valid from 5 April 1971.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
