# REGULATION (EEC) No 674/72 OF THE COMMISSION

#### of 30 March 1972

### amending Regulation (EEC) No 757/71 on special rules for granting aid for exports of skimmed milk powder for use as feed and skimmed milk processed into compound feedingstuffs

THE COMMISSION OF THE EUROPEAN COM-MUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No  $804/68^1$  of 27 June 1968 on the common organization of the market in milk and milk products, as last amended by Regulation (EEC) No 1410/71,<sup>2</sup> and in particular Article 10 (3) thereof;

Whereas, in accordance with Council Regulation (EEC) No 649/72<sup>3</sup> of 30 March 1972 fixing the aid for skimmed milk and skimmed milk powder for use as feed for the 1972/73 marketing year, the aid granted for skimmed milk powder which has been denatured or processed into compound feedingstuffs was increased, with effect from 1 April 1972, from 13 to 17.62 units of account per 100 kg;

Whereas the second subparagraph of Article 2 (1) of Council Regulation (EEC) No 986/68<sup>4</sup> of 15 July 1968 laying down general rules for granting aid for skimmed milk and skimmed milk powder for use as feed, as last amended by Regulation (EEC) No 673/71,<sup>5</sup> provides that an amount equivalent to the aid shall be levied on skimmed milk or skimmed milk powder exported in the form of denatured skimmed milk powder or compound feedingstuffs; whereas the amounts to be levied were fixed in the Annex to Commission Regulation (EEC) No 757/71<sup>6</sup> of 7 April 1971 on special rules for granting aid for exports of skimmed milk powder for use as feed and skimmed

milk processed into compound feedingstuffs, as last amended by Regulation (EEC) No 2469/717;

Whereas the amounts to be levied must be adjusted for the amount of the aid applicable from 1 April 1972; whereas however it is necessary to ensure that the new amounts are not levied on products which received the lower rate of aid previously applicable;

Whereas those provisions of Regulation (EEC) No 757/71 which govern customs procedure must be brought into line with the current version of Commission Regulation (EEC) No 1279/71<sup>8</sup> of 17 June 1971 on the use of Community transit documents for the purpose of applying certain measures on the exportation of certain goods, as amended by Regulation (EEC) No 2766/71<sup>9</sup>;

Whereas, for the sake of clarity, the provisions of Regulation (EEC) No 757/71 as they now stand should be published in full;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Milk and Milk Products;

HAS ADOPTED THIS REGULATION:

#### Article 1

The following shall be substituted for the provisions of Regulation (EEC) No 757/71:

#### 'Article 1

The amounts to be levied in accordance with the

second subparagraph of Article 2 (1) of Regulation (EEC) No 986/68 are fixed as shown in the Annex to this Regulation.

#### Article 2

1. The amount to be levied shall be that applicable on the day of completion of the customs formalities mentioned under (b) of the second subparagraph of Article 8 (2) of Regulation (EEC) No 1373/70. It shall be levied by the competent agency of the Member State on whose territory those formalities are completed.

2. The exporter shall pay the amount due not later than at the time of completion of the customs formalities referred to in paragraph 1.

#### Article 3

When the particulars entered on the customs document show that a product listed in the Annex will in the course of transport between two points in the Community leave Community territory other than by air, the sender shall lodge a deposit in an amount equal to that which would be levied if the product were exported from the Community.

## Article 4

Products listed in the Annex may be put into free circulation within the Community under the conditions laid down by Regulation (EEC) No 1279/71. In the cases referred to in Article 5a of that Regulation the day on which the customs formalities for the despatch of the products are completed shall be considered to be the day on which the customs formalities referred to in Article 2 are completed.'

#### Article 2

1. With effect from 1 April 1972 the Annex to this Regulation shall be substituted for the Annex to Regulation (EEC) No 757/71.

2. However, the amounts applicable up to that date shall continue to be applied to skimmed milk and skimmed milk powder if proof is supplied that they have qualified only for the aid applicable before 1 April 1972.

#### Article 3

This Regulation shall enter into force on 1 April 1972.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
