

REGULATION (EEC) No 1087/73 OF THE COMMISSION

of 26 April 1973

amending the Annex to Regulation No 199/67/EEC fixing the coefficients for calculating levies on derived poultrymeat products

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community ;

Having regard to Council Regulation No 123/67/EEC⁽¹⁾ of 13 June 1967 on the Common organization of the market in poultrymeat, as last amended by the Act⁽²⁾ concerning the conditions of Accession and the Adjustments to the Treaties, and in particular Article 5 (3) thereof ;

Whereas Council Regulation No 146/67/EEC⁽³⁾ of 21 June 1967, as last amended by Regulation (EEC) No 988/73⁽⁴⁾, laid down rules for calculating the levy and sluice-gate price for poultrymeat and whereas the last mentioned Regulation added the description '63 % ducks' to the Annexes to Regulation No 146/67/EEC for ducks which are plucked and drawn and without heads, feet, hearts, livers and gizzards and whereas halves and quarters of ducks under subheading 02.02 B II a) 2 of the Common Customs Tariff are derived from ducks falling within this description ;

Whereas it is therefore necessary to amend the Annex to Commission Regulation 199/67/EEC⁽⁵⁾ of 28 June

1967 fixing the coefficients for calculating the levies on derived poultrymeat products, as last amended by Regulation (EEC) No 1007/68⁽⁶⁾ of 19 July 1968, which classified halves and quarters of ducks as deriving from '70 % ducks' ;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Eggs and Poultrymeat ;

HAS ADOPTED THIS REGULATION :

Article 1

In column 4 of the Annex to Regulation No 199/67/EEC the description '70 % ducks' appearing in respect of unboned (bone in) halves or quarters of ducks under subheading 02.02 B II a) 2 of the Common Customs Tariff is replaced by '63 % ducks'.

Article 2

This Regulation shall enter into force on 1 May 1973.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
