

REGULATION (EEC) No 3310/74 OF THE COMMISSION
of 30 December 1974
fixing the import levies on milk and milk products

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 804/68 ⁽¹⁾ of 27 June 1968 on the common organization of the market in milk and milk products, as last amended by Regulation (EEC) No 662/74 ⁽²⁾, and in particular Article 14 (8) thereof;

Whereas the import levies on milk and milk products were fixed by Regulation (EEC) No 2537/74 ⁽³⁾, as last amended by Regulation (EEC) No 3150/74 ⁽⁴⁾;

Whereas it follows from applying the rules contained in Regulation (EEC) No 2537/74 to the prices known

to the Commission that the levies at present in force should be altered as shown in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION :

Article 1

The levies referred to in Article 14 (2) of Regulation (EEC) No 804/68 are hereby fixed as shown in the Annex.

Article 2

This Regulation shall enter into force on 1 January 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
