REGULATION (EEC) No 3322/74 OF THE COMMISSION

of 27 December 1974

Determining the amounts of the variable components, compensatory amounts and additional duties applicable during the first quarter of 1975 on the importation of goods covered by Regulation (EEC) No 1059/69

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to the Act ⁽¹⁾ annexed to the Treaty ⁽²⁾ concerning the accession of new Member States to the European Economic Community and to the European Atomic Energy Community, signed at Brussels on 22 January 1972, and in particular Article 47 thereof;

Having regard to Council Regulation (EEC) No 1059/69 ⁽³⁾ of 28 May 1969 laying down the trade arrangements applicable to certain goods resulting from the processing of agricultural products, as last amended by Council Regulation (EEC) No 1491/73 ⁽⁴⁾, and in particular Articles 6 and 8 thereof;

Having regard to Council Regulation (EEC) No 232/73 ⁽⁵⁾ of 31 January 1973 on the implementation of Article 47 of the Act as regards the system of trade applicable to goods covered by Regulation (EEC) No 1059/69, as amended by Council Regulation (EEC) No 2989/74 ⁽⁶⁾ of 26 November 1974, and in particular Articles 2 and 3 thereof;

Whereas pursuant to the first subparagraph of Article 47 (1) of the Act any accession compensatory amount applicable in trade between the Community as originally constituted and the new Member States, or

in trade between the new Member States themselves, to goods covered by Regulation (EEC) No 1059/69 is to be determined on the basis of the compensatory amounts referred to in Article 55 (1) (a) of the said Act and in accordance with the rules laid down in that Regulation for the calculation of the variable component applicable to the goods in question;

Whereas under the second subparagraph of the said Article 47 (1) the variable component is to be on importation into the new Member States from third countries reduced by the accession compensatory amount applicable on importation of the same goods from the new Member States into the Community as originally constituted;

Whereas the rules for calculating the variable component applicable to each of the goods covered by Regulation (EEC) No 1059/69 are laid down in Article 6 (1) and (2) of that Regulation;

Whereas Council Regulation (EEC) No 1060/69 ⁽⁷⁾ of 28 May 1969, as last amended by Regulation (EEC) No 2067/71 ⁽⁸⁾, fixes the quantities of the basic products considered as having been used in the manufacture of goods covered by Regulation (EEC) No 1059/69;

Whereas the average accession compensatory amounts to be taken into account during January, February and March 1975 for the basic products mentioned in Article 2 of Regulation (EEC) No 1059/69 are as follows:

Whereas the first subparagraph of Article 6 (3) of Regulation (EEC) No 1059/69 provides that where, pursuant to the Regulations on the common organization of markets, a production refund or an aid is applicable in all Member States to basic products or to products assimilated thereto under Article 3 of that Regulation, the amount of the variable component shall be calculated by reference to the price resulting from the application of those measures instead of by reference to the average threshold price; whereas Article 3 of Regulation (EEC) No 1060/69 specifies the goods to which these provisions are applicable;

Whereas the first subparagraph of Article 1 (1) of Council Regulation (EEC) No 1132/74 ⁽¹⁾ of 29 April 1974 on production refunds in the cereals and rice sectors, as last amended by Regulation (EEC) No 2518/74 ⁽²⁾, provides that Member States shall grant a production refund on maize for the manufacture of starch equal to the difference per 100 kg between the threshold price for this cereal and 8.745 units of account; whereas, pursuant to the second subparagraph of Article 14 (3) of Regulation (EEC) No 1059/69, in determining the amounts of the variable components the increase in the refund granted in

Italy under the second subparagraph of Article 1 (1) of Regulation (EEC) No 1132/74 is not to be taken into account;

Whereas pursuant to Article 5 of Council Regulation (EEC) No 765/68 ⁽³⁾ of 18 June 1968 laying down general rules for the production refund on sugar used in the chemical industry, as last amended by Regulation (EEC) No 2477/74 ⁽⁴⁾, until 30 June 1975 white sugar to be used in the manufacture of products as specified in Annex I to that Regulation is to be supplied to the chemical industry at a price equal to 16 units of account per 100 kg;

Whereas as regards the basic products specified in Article 2 of Regulation (EEC) No 1059/69 the averages, as calculated for the period comprising the months of October and November 1974 and the first 10 days of December, for cif prices (excluding special cif prices), or as the case may be free-at-frontier prices, used in fixing the levies applicable to each such basic product are as follows:

Whereas the Common Customs Tariff provides in the case of certain goods covered by Regulation (EEC) No 1059/69 for a maximum duty comprising an additional duty on their sugar content expressed in terms of sucrose (ads) or on their flour content (adf); whereas the rules for calculating such additional duties are set out in Article 8 (2) and (3) of that Regulation; whereas pursuant to Article 8 (4) of that same Regulation the Commission is to determine each quarter the amount of the additional duties and the price differences used in calculating those additional duties;

Whereas the average threshold prices for common wheat flour and for rye flour to be taken into consideration for January, February and March 1975 are as follows:

Whereas pursuant to Article 3 (2) (b) of Regulation (EEC) No 232/73 the variable component of the maximum charge applicable on importation into the new Member States from third countries is to be equal to the additional duty mentioned in Article 8 (2) of Regulation (EEC) No 1059/69, less the accession compensatory amount relating to the quantity of sugar or flour to which this additional duty applies;

Whereas for January, February and March 1975 the average accession compensatory amounts applicable to common wheat flour and rye flour on importation into the Community as originally constituted from the new Member States are as follows:

Whereas pursuant to Article 4 of Regulation (EEC) No 232/73 the accession compensatory amounts applicable in intra-Community trade to the goods shown in Annex IV of the said Regulation are calculated, in certain conditions, on the basis of the information given in that Annex,

HAS ADOPTED THIS REGULATION:

Article 1

For the period 1 January to 31 March 1975 inclusive and in respect of goods covered by Regulation (EEC) No 1059/69 the variable components applicable on importation from third countries and the accession compensatory amounts applicable in trade between the Community as originally constituted and the new Member States and in trade between the new Member States shall be as specified in units of account in Annex I to this Regulation.

Article 2

1. For the period 1 January to 31 March 1975 inclusive, the amounts of the additional duties as referred to in Article 8 (2) of Regulation (EEC) No 1059/69 on various kinds of sugar expressed as sucrose (ads), or on flour (adf), applicable on importation:

(a) into the Community as originally constituted from third countries, shall be as specified in units of account in Annex II;

(b) into the new Member States from third countries, shall be as specified in units of account in Annex III.

2. For the period 1 January to 31 March 1975 inclusive, the differences in prices for white sugar and for common wheat flour and rye flour, as referred to in Article 8 (2) (a) of Regulation (EEC) No 1059/69, to be taken into account on importation:

(a) into the Community as originally constituted from third countries, shall be as specified in units of account in Annex IV;

(b) into the new Member States from third countries, shall be as specified in units of account in Annex V.

Article 3

This Regulation shall enter into force on 1 January 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
