

## REGULATION (EEC) No 3325/74 OF THE COMMISSION

of 20 December 1974

fixing the standard values to be used in calculating financial compensation in respect of fishery products withdrawn from the market during the 1975 fishing year

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 2142/70<sup>(1)</sup> of 20 October 1970 on the common organization of the market in fishery products, as last amended by Regulation (EEC) No 2682/74<sup>(2)</sup>, and in particular Article 10 (5) thereof;

Whereas Article 10 of Regulation (EEC) No 2142/70 provides for the grant of financial compensation to producers' organizations which intervene, in certain conditions, in respect of the products listed in Annex I (A) and (C) to that Regulation; whereas the amount of financial compensation must be reduced by standard values in the case of products for purposes other than human consumption;

Whereas Commission Regulation (EEC) No 697/71<sup>(3)</sup> of 31 March 1971 specifies the ways in which the products withdrawn may be disposed of; whereas the value of such products must be fixed at a standard level for each of these modes of disposal, taking into account the average receipts which may be obtained from such disposal;

Whereas Commission Regulation (EEC) No 2854/73<sup>(4)</sup> of 19 October 1973 fixed the standard values for 1974;

Whereas market information relating to those values shows that for most of the uses in question they have been altered during the period just passed; whereas the standard values for 1975 should therefore be fixed in the light of receipts in that period;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Fishery Products,

HAS ADOPTED THIS REGULATION:

*Article 1*

For the year 1975 the standard values to be used in calculating the financial compensation provided for in Article 10 of Regulation (EEC) No 2142/70 in respect of products withdrawn by producers' organizations and used for purposes other than human consumption, shall be as shown in the Annex hereto.

*Article 2*

This Regulation shall enter into force on 1 January 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
