

REGULATION (EEC) No 2010/75 OF THE COMMISSION
of 30 July 1975

amending, with regard to Ireland and the United Kingdom, Annex I to Regulation (EEC) No 1896/73 on detailed rules for the application of intervention measures on the market in beef and veal

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 805/68⁽¹⁾ of 27 June 1968 on the common organization of the market in beef and veal, as last amended by Regulation (EEC) No 1855/74⁽²⁾, and in particular Article 6(5) thereof;

Whereas the coefficients provided for in Article 6(1) and (2) of Regulation (EEC) No 805/68 for certain categories of animals were fixed in Annex I to Commission Regulation (EEC) No 1896/73⁽³⁾ of 13 July 1973 on detailed rules for application of intervention measures on the market in beef and veal, as last amended by Regulation (EEC) No 1751/75⁽⁴⁾; whereas Article 3(3) of Council Regulation (EEC) No 1302/73⁽⁵⁾ of 15 May 1973 laying down general rules for intervention on the market in beef and veal, as amended by Regulation (EEC) No 1729/74⁽⁶⁾, lays down that those coefficients must be reviewed and, if necessary, adjusted in order to harmonize buying-in prices in the Community;

Whereas in order not to disturb the development of the beef markets in Ireland and the United Kingdom a revision of the coefficients used to calculate the intervention buying-in must be applied; whereas the price difference for 'Heifers' especially in these two States are not in keeping with reality;

Whereas the date of entry into force of those new coefficients should be made to coincide with that of the change in prices already resulting in both Member States concerned from the new representative rates;

Whereas the Management Committee for Beef and Veal has not delivered an opinion within the time limit set by its Chairman,

HAS ADOPTED THIS REGULATION:

Article 1

For the products listed below, the coefficients listed in Annex 1 to Regulation (EEC) No 1896/73 are amended as follows:

'IRELAND:

Heifers 2	0.91
Steers 1	0.96
Steers 2	0.95
Cows 1	0.77

'UNITED KINGDOM:

(a) Great Britain:

Steers M	0.96
Steers H	0.95
Heifers M/H	0.93

(b) Northern Ireland:

Steers L/M	0.95
Steers L/H	0.95
Steers T	0.93
Heifers T	0.90

Article 2

This Regulation shall enter into force on 4 August 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
