

REGULATION (EEC) No 2119/75 OF THE COMMISSION
of 12 August 1975
altering the export levy on white sugar and raw sugar

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 3330/74⁽¹⁾ of 19 December 1974 on the common organization of the market in sugar, and in particular Article 17 (6) thereof;

Having regard to Council Regulation (EEC) No 608/72⁽²⁾ of 23 March 1972 laying down rules to be applied in cases of considerable price rises on the world sugar market, and in particular Article 1 (2) thereof;

Whereas, pursuant to Article 17 (1) of Regulation (EEC) No 3330/74, where the Community or any region thereof cannot be supplied with sugar at prices within the limit of the threshold price, provision may be made for charging a special export levy on sugar;

Whereas the threshold price for white sugar and raw sugar was fixed by Regulation (EEC) No 660/75⁽³⁾;

Whereas the list of products subject to the special levy is given in Commission Regulation (EEC) No

825/75⁽⁴⁾ of 25 March 1975 laying down detailed rules for applying export levies on sugar;

Whereas the export levy on white sugar and raw sugar was fixed by Regulation (EEC) No 1702/75⁽⁵⁾, as last amended by Regulation (EEC) No 2105/75⁽⁶⁾;

Whereas it follows from applying the rules, criteria and other provisions contained in the Regulation (EEC) No 1702/75 to the information at present available to the Commission, that the export levy at present in force should be altered as shown in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION:

Article 1

The export levy on sugar provided for in the first subparagraph of Article 17 (1) of Regulation (EEC) No 3330/74 is fixed as shown in the Annex to this Regulation.

Article 2

This Regulation shall enter into force on 13 August 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
