

REGULATION (EEC) No 3233/75 OF THE COMMISSION
of 11 December 1975
fixing the import levies on rice and broken rice

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 359/67/EEC⁽¹⁾ of 25 July 1967 on the common organization of the market in rice, as last amended by Regulation (EEC) No 668/75⁽²⁾, and in particular Article 11 (5) thereof;

Whereas the import levies on rice and broken rice were fixed by Regulation (EEC) No 2231/75⁽³⁾ and subsequent amending Regulations;

Whereas it follows from applying the rules and other provisions contained in Regulation (EEC) No 2231/75 to the offer prices and today's quotations known to

the Commission that the levies at present in force should be altered as shown in the table annexed to this Regulation,

HAS ADOPTED THIS REGULATION:

Article 1

The import levies to be charged on the products listed in Article 1 (1) (a) and (b) of Regulation No 359/67/EEC are hereby fixed as shown in the table annexed to this Regulation.

Article 2

This Regulation shall enter into force on 12 December 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
