

REGULATION (EEC) No 861/75 OF THE COMMISSION
of 2 April 1975
altering the export refunds on products processed from cereals and rice

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community ;

Having regard to Council Regulation No 120/67/EEC⁽¹⁾ of 13 June 1967 on the common organization of the market in cereals, as last amended by Regulation (EEC) No 85/75⁽²⁾, and in particular the second sentence of the fourth subparagraph of Article 16 (2) thereof ;

Having regard to Council Regulation No 359/67/EEC⁽³⁾ of 25 July 1967 on the common organization of the market in rice, as last amended by Regulation (EEC) No 476/75⁽⁴⁾, and in particular the second sentence of the fourth subparagraph of Article 17 (2) thereof ;

Whereas the export refunds on products processed from cereals and rice were fixed by Regulation (EEC) No 793/75⁽⁵⁾, as amended by Regulation (EEC) No 851/75⁽⁶⁾ ;

Whereas it follows from applying the rules, criteria and other provisions contained in Regulation (EEC) No 793/75 to the information at present available to the Commission that the export refunds at present in force should be altered as shown in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION :

Article 1

The export refunds on the products listed in Article 1 (d) of Regulation No 120/67/EEC and in Article 1 (1) (c) of Regulation No 359/67/EEC and subject to Regulation (EEC) No 1052/68⁽⁷⁾, as fixed in the Annex to amended Regulation (EEC) No 793/75, are hereby altered to the amounts shown in the Annex to this Regulation.

Article 2

This Regulation shall enter into force on 3 April 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
