

**COMMISSION REGULATION (EEC) No 2023/78**  
**of 25 August 1978**  
**fixing the import levies on frozen beef and veal**

THE COMMISSION OF THE EUROPEAN  
COMMUNITIES,

Having regard to the Treaty establishing the European  
Economic Community,

Having regard to Council Regulation (EEC) No  
805/68 of 27 June 1968 on the common organization  
of the market in beef and veal <sup>(1)</sup>, as last amended by  
Regulation (EEC) No 425/77 <sup>(2)</sup>, and in particular  
Article 12 (8) thereof,

Whereas the import levies on frozen beef and veal  
were fixed by Regulation (EEC) No 1016/78 <sup>(3)</sup>, as last  
amended by Regulation (EEC) No 1773/78 <sup>(4)</sup>;

Whereas it follows from applying the rules and other  
provisions contained in Regulation (EEC) No 1016/78

to the quotations and other information known to the  
Commission, that the levies should be fixed as shown  
in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION :

*Article 1*

The import levies on frozen beef and veal shall be as  
specified in the Annex to this Regulation.

*Article 2*

This Regulation shall enter into force on 4 September  
1978.

This Regulation shall be binding in its entirety and directly applicable in all Member  
States.
