## COMMISSION REGULATION (EC) No 524/95

## of 8 March 1995

altering the basic amount of the import levies on syrups and certain other products in the sugar sector

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 1785/81 of 30 June 1981 on the common organization of the markets in the sugar sector (1), as last amended by Regulation (EC) No 283/95 (2), and in particular Article 16 (8) thereof,

Having regard to Council Regulation (EEC) No 3813/92 of 28 December 1992 on the unit of account and the conversion rates to be applied for the purposes of the common agricultural policy (3), as last amended by Regulation (EC) No 150/95 (4), and in particular Article 5 thereof,

Whereas the import levies on syrups and certain other sugar products were fixed by Commission Regulation (EC) No 425/95 (5), as last amended by Regulation (EC) No 503/95 (9);

Whereas it follows from applying the detailed rules contained in Regulation (EC) No 425/95 to the information known to the Commission that the basic amount of the levy on syrups and certain other sugar products at present in force should be altered;

Whereas, in order to make it possible for the levy arrangements to function normally, the representative market rate established during the reference period from 7 March 1995, as regards floating currencies, should be used to calculate the levies,

### HAS ADOPTED THIS REGULATION:

#### Article 1

The basic amounts of the import levy on the products listed in Article 1 (1) (d) of Regulation (EEC) No 1785/81, as fixed in the Annex to amended Regulation (EC) No 425/95 are hereby altered to the amounts shown in the Annex hereto.

### Article 2

This Regulation shall enter into force on 9 March 1995.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
