Section 2

Disputes concerning the infringement and validity of [^{F1}supplementary unregistered] designs

Article 86

Judgements of invalidity

1 Where in a proceeding before a ^{F1}... design court the [^{F2}supplementary unregistered] design has been put in issue by way of a counterclaim for a declaration of invalidity:

- a if any of the grounds mentioned in Article 25 are found to prejudice the maintenance of [^{F3}that] design, the court shall declare [^{F3}that] design invalid;
- b if none of the grounds mentioned in Article 25 is found to prejudice the maintenance of [^{F4}that] design, the court shall reject the counterclaim.
