THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2019/1700 of the European Parliament and of the Council of 10 October 2019 establishing a common framework for European statistics relating to persons and households, based on data at individual level collected from samples, amending Regulations (EC) No 808/2004, (EC) No 452/2008 and (EC) No 1338/2008 of the European Parliament and of the Council, and repealing Regulation (EC) No 1177/2003 of the European Parliament and of the Council and Council Regulation (EC) No 577/98⁽¹⁾, and in particular Article 7(1) thereof,

Whereas:

- (1) To ensure the accurate implementation of the sample survey in the labour force domain, the Commission should specify the technical items of the data set.
- (2) The Commission should establish the technical items of the data set for the 2022 ad hoc subject ‘job skills’ and for the eight-yearly variables on ‘pension and labour market participation’ in the labour force domain.
- (3) The measures provided for in this Regulation are in accordance with the opinion of the European Statistical System Committee,

HAS ADOPTED THIS REGULATION:

Article 1

The technical items of the data set for the 2022 ad hoc subject ‘job skills’ and for the eight-yearly variables on ‘pension and labour market participation’ in the labour force domain are set out in the Annex.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.
