THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1059/2003 of the European Parliament and of the Council of 26 May 2003 on the establishment of a common classification of territorial units for statistics (NUTS)⁽¹⁾, and in particular Article 5(5) thereof,

Whereas:

- (1) Regulation (EC) No 1059/2003 provides the legal framework for the regional classification in order to enable the collection, compilation and dissemination of harmonised regional statistics in the Union.
- (2) The Commission has amended the common classification of territorial units for statistics (NUTS) by Commission Delegated Regulation (EU) 2019/1755⁽²⁾ with effect from 1 January 2021.
- (3) The measures provided for in this Regulation are in accordance with the opinion of the European Statistical System Committee,

HAS ADOPTED THIS REGULATION:

Article 1

Member States shall transmit to the Commission (Eurostat) the time series for the new regional breakdown in accordance with the Annex by 1 January 2023.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
