**Orders**

**61.**—(1) Orders made under Articles 3(2), [<sup>F1</sup>4A(1), 4B(3),] 8(1), [<sup>F2</sup>8A(1),] 13, 16<sup>F3</sup> (1A) or] (2), [<sup>F4</sup>16A(1) or (3), 19A(1), 32A, 32B(1), 32D(7), 32E(2), 32F(5), 32I(1),]<sup>F5</sup> . . . 33(3), 34, 36(1) (c), [<sup>F6</sup>39(3), 48A(2) and 50(1)] and any order made under Article 2(3) which modifies Schedule 2 so as to extend the provisions of this Order shall be subject to negative resolution.

(2) An order of the Department in relation to the landing or conveyance of imported animals or poultry shall be laid before the Assembly.

(3) Where the Department makes an order under this Order which is not subject to negative resolution under paragraph<sup>F3</sup> (1)], the Department shall publish in the Belfast Gazette a notice stating that the order has been made and the place where copies of the order may be obtained; but the validity or effect of such an order or of any licence or other instrument issued by the Department shall not be affected by want of, or defect or irregularity in, any publication.
