Adoption societies

Inactive or defunct adoption societies

- **8.**—(1) If it appears to the Department that a [FI body which is or has been an appropriate voluntary organisation] is inactive or defunct, the Department may, in relation to any child who is or was in the care of the [F2 organisation], direct [F3 an] [F4 HSC trust] to take such action as might have been taken by the [F2 organisation] or by the [F2 organisation] jointly with some other body (including [F3 an] [F4 HSC trust]).
- (2) Before giving a direction under paragraph (1), the Department shall, if practicable, consult both the [F2 organisation] and the F5... [F4HSC trust].
