NATIONAL INSURANCE (INDUSTRIAL INJURIES)**Insurable and Excepted Employments**

REGULATIONS, DATED 1ST FEBRUARY 1974, MADE BY THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES UNDER THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACT (NORTHERN IRELAND) 1966.

The Department of Health and Social Services, in exercise of powers conferred by section 74(1) of the National Insurance (Industrial Injuries) Act (Northern Ireland) 1966(a), and of all other powers enabling it in that behalf, hereby makes the following regulations being regulations subject to negative resolution in accordance with section 80(2) of that Act:

Citation and commencement

1. These regulations may be cited as the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Amendment Regulations (Northern Ireland) 1974 and shall come into operation on 4th February 1974.

Amendment of the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Regulations

2.—(1) Schedule 3 to the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Regulations (Northern Ireland) 1973(b) (which sets out in column 2 the persons who are to be treated as employers of persons employed in employments specified in column 1) shall be amended in accordance with paragraphs (2) and (3).

(2) In paragraph 3(b) in column 2 after the words “in any other case,” there shall be inserted the words “except where the employment is also one specified in paragraph 5 in column 1.”

(3) After paragraph 4 there shall be added—

(a) in column 1 the following paragraph:

“5. Employment (not being employment in respect of which an employer, in any particular case, is prescribed in paragraph 3(a) in column 2, and not being employment specified in paragraph 4 in column 1) by a company, being a company within the meaning of the Companies Act (Northern Ireland) 1960(c) and in voluntary liquidation but carrying on business under a liquidator.”; and

(b) in column 2 the following paragraph:

“5. The person who at the time of the employment holds the office of liquidator.”

EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

These regulations amend the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Regulations (Northern Ireland) 1973 by providing for the holder of the office of liquidator of a company in voluntary liquidation but carrying on business to be treated as the employer of persons employed by the company at the time and makes a minor amendment consequential thereto.
