## HOUSING

**Housing (Grants) Order (Northern Ireland) 1974**

*Made* . . . . . 30th October 1974

*Coming into operation* . . . . . 1st January 1975

*To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974.*

The Department of Housing, Local Government and Planning (in this Order referred to as "the Department") with the approval of the Department of Finance in exercise of the powers conferred on it by section 15 of the Housing (No. 2) Act (Northern Ireland) 1946(a) (in this Order referred to as "the No. 2 Act of 1946") and of every other power enabling it in that behalf hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as the Housing (Grants) Order (Northern Ireland) 1974 and shall come into operation on the 1st January 1975.

*Contributions payable to persons in respect of houses built for letting*

2. The contributions payable by a district council in respect of housing accommodation provided for workers in accordance with the provisions of section 1(1) of the Housing and Local Government (Miscellaneous Provisions) Act (Northern Ireland) 1946(b) and the sums payable by the Department under section 1(2) of that Act to the district council in respect of those contributions shall, in relation to each new house completed between the 1st January 1975 and the 31st December 1975 inclusive and falling within any one of the three categories mentioned in the first column of Schedule 1, consist respectively of a single payment of the amount specified opposite such category in the second and third columns of Schedule 1.

*Grants payable to persons in respect of houses built for owner occupation*

3. The grant payable by a district council under section 6(1) of the No. 2 Act of 1946, and the sum payable by the Department under section 6(2) of that Act to the district council in respect of this grant shall, in relation to each new house completed between the 1st January 1975 and the 31st December 1975 inclusive and falling within any one of the three categories mentioned in the first column of Schedule 2, be respectively the amount specified opposite such category in the second and third columns of Schedule 2.
