Teachers' Superannuation (Amendment) Regulations (Northern Ireland) 1975

Made 6th February 1975

Coming into operation 21st March 1975

The Department of Education in exercise of the powers conferred upon it by articles 11 and 14 of the Superannuation (Northern Ireland) Order 1972(a) and all other powers enabling it in that behalf, and after consultation with representatives of education and library boards and of teachers and with such representatives of other persons likely to be affected as required by article 11(5) of the said Order and with the consent of the Department of Finance, hereby makes the following Regulations:

Citation and commencement

1. These regulations may be cited as the Teachers' Superannuation (Amendment) Regulations (Northern Ireland) 1975 and shall come into operation on 21st March 1975.

Amendment of the Teachers' Superannuation (Added years and Interchange) Regulations (Northern Ireland) 1974

2. The Teachers' Superannuation (Added years and Interchange) Regulations (Northern Ireland) 1974(b) shall have effect with the following amendments:

- (a) in regulation 3(4) after the words "Teachers Regulations" there shall be added the words "to a man teacher over the age of sixty-five and to a woman teacher over the age of sixty";
- (b) in regulation 28 after the words "Department of Finance" there shall be added the words "or from" and after the words "Social Services" in line 5 there shall be deleted all the words up to and including the words "Secretary of State for Scotland".

Amendment of the Teachers' Superannuation (Amending) Regulations (Northern Ireland) 1974

3. The Teachers' Superannuation (Amending) Regulations (Northern Ireland) 1974(c) shall have effect with the substitution in regulation 1(1) for the words "1st April 1974" of the words "1st December 1973".

EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

Regulation 2(a) clarifies the position that a reduction in a teacher's superannuation allowance on account of modification does not have effect until the teacher reaches the age of sixty-five in the case of a man and sixty in the case of a woman.

Regulation 2(b) provides for transfer values in respect of Northern Ireland teachers transferring to and from certain employments in Great Britain to be paid or received on a cash basis and not notionally as previously provided.

Regulation 3 provides for the reduction of the teachers contribution to 6% to have effect from 1st December 1973, and has retrospective effect by virtue of Article 14(1) of the Superannuation (Northern Ireland) Order 1972.
