LOCAL GOVERNMENT**Chief Administrative Public Health Inspectors (Qualifications) Regulations
(Northern Ireland) 1975***Made* 16th September 1975*Coming into operation* 31st October 1975

The Department of Housing, Local Government and Planning^(a) in exercise of the powers conferred on it by section 41 of the Local Government Act (Northern Ireland) 1972^(b) and of every other power enabling it in that behalf, hereby makes the following regulations:

Citation

1. These regulations may be cited as the Chief Administrative Public Health Inspectors (Qualifications) Regulations (Northern Ireland) 1975 and shall come into operation on 31st October 1975.

Interpretation

2. In these regulations "Chief Administrative Public Health Inspector" means an officer appointed in accordance with Article 4 of the Local Government (Employment of Public Health Inspectors) Order (Northern Ireland) 1973^(c).

Qualifications

3. A person shall not be qualified to be appointed to the office of Chief Administrative Public Health Inspector unless—

(a) he possesses one or more of the following qualifications:

- (i) The Certificate or Diploma of the Public Health Inspectors' Education Board;
- (ii) The Sanitary Inspectors' Certificate of the Royal Sanitary Institute and Sanitary Inspectors' Examination Joint Board;
- (iii) The Sanitary Inspectors' Certificate of the Sanitary Inspectors' Examination Board;
- (iv) The Diploma in Environmental Health of the Environmental Health Officers' Education Board;
- (v) The Certificate of Registration of the Environmental Health Officers' Registration Board;
- (vi) The Certificate of the Royal Sanitary Association of Scotland;
- (vii) The Sanitary Inspectors' Certificate of the Royal Sanitary Institute for appointments outside England and Wales; and

(b) he has had not less than 10 years experience as a public health inspector since obtaining one of the qualifications mentioned in subparagraph (a).
