REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES**Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1975***Made* 14th October 1975*Coming into operation* 1st December 1975*To be laid before Parliament under paragraph 3(3) of
Schedule 1 to the Northern Ireland Act 1974.*

In exercise of the powers conferred upon me by section 1 of the Registration of Births, Deaths and Marriages (Fees, etc.) Act (Northern Ireland) 1955(a) and by section 62 of the Births and Deaths Registration Act (Northern Ireland) 1967(b) as amended by the Births, Deaths and Marriages Registration (Northern Ireland) Order 1973(c) and modified by paragraph 4 of Schedule 5 to the Northern Ireland Constitution Act 1973(d) I hereby make the following Order:

Citation and commencement

1. This Order may be cited as the Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1975 and shall come into operation on 1st December 1975.

Fees payable

2. The amounts of the fees payable under the several enactments set forth in the second column of the Schedule in respect of the services described in the third column thereof shall be those specified respectively in the fourth column thereof.

Revocation of Order

3. The Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1973(e) is hereby revoked.
