**Agricultural Development Loans (Amendment) Scheme  
(Northern Ireland) 1975**

*Made* . . . . . 19th November 1975

*Coming into operation* . . . . . 31st December 1975

The Department(a) of Agriculture in exercise of the powers conferred on it by section 1 of the Development Loans (Agriculture and Fisheries) Act (Northern Ireland) 1968(b) and of every other power enabling it in that behalf, and with the approval of the Department(a) of Finance hereby makes the following Scheme:

*Citation and commencement*

1. This Scheme may be cited as the Agricultural Development Loans (Amendment) Scheme (Northern Ireland) 1975 and shall come into operation on 31st December 1975.

*Amendments*

2. The Schemes referred to in the Schedule shall have effect subject to the amendments specified therein.

*Revocations*

3. The following Schemes are hereby revoked:

The Agricultural Development Loans (Rural and Agricultural Industries) (Hire Purchase) Scheme (Northern Ireland) 1962(c).

The Agricultural Development Loans (Rural and Agricultural Industries) Scheme (Northern Ireland) 1964(d).

## SCHEDULE

## Article 2

## Amendments

1. In Article 4(7) of the Agricultural Development Loans (Livestock) Scheme (Northern Ireland) 1962(e), for "£2,000" substitute "£5,000".
2. In Article 4(4) of the Agricultural Development Loans (Seeds and Fertilisers) Scheme (Northern Ireland) 1962(f), for "£2,000" substitute "£5,000".
3. In Article 4(7) of the Agricultural Development Loans (Byre and Dairy) Scheme (Northern Ireland) 1962(g), for "£2,000" substitute "£7,000".
4. In Article 4(5) of the Agricultural Development Loans (Farm Dwellings) Scheme (Northern Ireland) 1962(h), for "£2,500" substitute "£7,000".
5. In Article 4(6) of the Agricultural Development Loans (Small Agricultural Industries) Scheme (Northern Ireland) 1962(i), for "£3,000" substitute "£5,000".
6. In Article 4(5) of the Agricultural Development Loans (Private Woodlands) Scheme (Northern Ireland) 1962(j), for "£2,000" substitute "£5,000".
7. In Article 4(5) of the Agricultural Development Loans (Electrical Plant and Machinery) Scheme (Northern Ireland) 1962(k), for "£2,000" substitute "£5,000".
8. In Article 4(5) of the Agricultural Development Loans (Farm Structures) Scheme (Northern Ireland) 1963(l), for "£2,000" substitute "£7,000".
9. In Article 3(4) of the Agricultural Development Loans (Agricultural Shows) Scheme (Northern Ireland) 1965(m), for "£3,000" substitute "£5,000".
10. In Article 5(1) of the Agricultural Development Loans (Machinery and Equipment) (Hire Purchase) Scheme (Northern Ireland) 1967(n), for "£2,000" substitute "£5,000".
11. For Article 4 of the Agricultural Development Loans (Amalgamations) Scheme (Northern Ireland) 1967(o) there shall be substituted the following Article:

"4.—(1) The amount of any loan made under this Scheme shall not exceed £10,000 except with the special sanction of the Department of Finance.

(2) Security for any loan and the rate of interest thereon shall be such as the Department with the approval of the Department of Finance may determine."

EXPLANATORY NOTE

*(This note is not part of the Scheme but is intended to indicate its general purport.)*

This Scheme amends certain Schemes, made under the Development Loans (Agriculture and Fisheries) Act (Northern Ireland) 1968, to increase the size of the loans which may be made by the Department, without reference to the Department of Finance. The Scheme also revokes two loans Schemes, for which there is no longer any requirement.
