**Teachers' Superannuation (Teachers' Interchange) (Revocation)
Regulations (Northern Ireland) 1975**

Made 5th March 1975

Coming into operation 16th April 1975

The Department of Education(a) in exercise of the powers conferred upon it by Article 11 and by Article 23 and Schedule 7 of the Superannuation (Northern Ireland) Order 1972(b) and of all other powers enabling it in that behalf, and after consultation with representatives of education and library boards and of teachers and with such representatives of other persons likely to be affected as required by Article 11(5) of the said Order, and with the consent of the Department of Finance, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Teachers' Superannuation (Teachers' Interchange) (Revocation) Regulations (Northern Ireland) 1975 and shall come into operation on 16th April 1975.

2.—(1) The rules specified in the schedule are hereby revoked.

(2) Paragraph (1) shall not affect the operation of the rules thereby revoked in relation to any person who became, or ceased to be, employed as a teacher in reckonable service before 1st April 1972.

EXPLANATORY NOTE

(This note is not part of the regulations but is intended to indicate their general purport.)

These regulations revoke the rules specified in the schedule, which contain provisions relating to the pensions of persons transferring between teaching and employments to which those rules apply. Those provisions have now been superseded by the Teachers' Superannuation (Added Years and Interchange) Regulations (Northern Ireland) 1974 [S.R. 1974 No. 185].
