REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES**Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1976**

Made 5th November 1976

Coming into operation 1st January 1977

*To be laid before Parliament under paragraph 3(3) of
Schedule 1 to the Northern Ireland Act 1974.*

In exercise of the powers conferred upon me by section 1 of the Registration of Births, Deaths and Marriages (Fees, etc.) Act (Northern Ireland) 1955(a) as modified by section 40 of, and Paragraph 4 of Schedule 5 to, the Northern Ireland Constitution Act 1973(b) and Article 47 of the Births and Deaths Registration (Northern Ireland) Order 1976(c) I hereby make the following Order:

Citation and commencement

1. This Order may be cited as the Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1976 and shall come into operation on 1st January 1977.

Fees Payable

2. The amounts of the fees payable under the several enactments set forth in the second column of the Schedule in respect of the services described in the third column thereof shall be those specified respectively in the fourth column thereof.

Revocation of Order

3. The Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1975(d) is hereby revoked.
