Cattle (Breeding Herds) (Revocation) Scheme (Northern Ireland) 1976

Made 23rd December 1976

Coming into operation 31st December 1976

The Department of Agriculture, in exercise of the powers conferred on it by section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) as amended by the Agriculture (Temporary Assistance) (Amendment) Act (Northern Ireland) 1957(b) and now vested in it(c) and of every other power enabling it in that behalf, and with the approval of the Department(d) of Finance, hereby makes the following Scheme:

Citation and commencement

1.—(1) This Scheme may be cited as the Cattle (Breeding Herds) (Revocation) Scheme (Northern Ireland) 1976.

(2) This Scheme shall come into operation on 31st December 1976.

EXPLANATORY NOTE
