The Department of the Environment in exercise of the powers conferred by Section 17 of the Fire Services Act (Northern Ireland) 1969(a) and now vested in it(b) and of every other power enabling it in that behalf and with the approval of the Department of the Civil Service(c) hereby makes the following Order:

Citation, commencement and effect

1. This Order may be cited as the Firemen's Pension Schemes (Amendment No. 2) Order (Northern Ireland) 1978 and shall come into operation on 25th April 1978 and shall have effect from 1st December 1977.

Interpretation

- 2. In this Order—
- "Scheme of 1973" means the Firemen's Pension Scheme (Northern Ireland) 1973 as set out in Appendix 2 to the Firemen's Pension Scheme Order (Northern Ireland) 1973(d);
- "Scheme of 1971" means the Firemen's Pension Scheme (Northern Ireland) 1971 as set out in the Appendix to the Firemen's Pension Scheme Order (Northern Ireland) 1971(e);
- "Scheme of 1955" means the Scheme set out in the Schedule to the Fire Services (Fire Officers and Firemen) Pensions Order (Northern Ireland) 1955(f); and
- "Belfast Fire Brigade Scheme" means the Belfast Fire Brigade Superannuation Scheme made on 1st May 1953 by the Council of the County Borough of Belfast under section 13 of the Fire Services (Amendment) Act (Northern Ireland) 1950(g) and that or any Scheme maintained by the said Council under section 26(3) of the Fire Services Act (Northern Ireland) 1969.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

Under the various Firemen's Pension Schemes the amount of certain awards is determined by reference to specified flat rates which do not qualify for increases under the Pensions (Increase) Act (Northern Ireland) [1971 c. 35 (N.I.)]. The Order increases these flat rates with effect from 1st December 1977, the date from which increases under the Pensions Increase (Annual Review) Order (Northern Ireland) 1977 were authorised.

Retrospection is authorised by Section 17(3B) of the Fire Services Act (Northern Ireland) 1969.
