## ROAD TRAFFIC AND VEHICLES

Off-Street Parking (Amendment) (No. 5) Bye-Laws  
(Northern Ireland) 1978*Made* . . . . . 25th October 1978*Coming into operation* . . . . . 13th November 1978

The Department of the Environment in exercise of the powers conferred by Section 89 of the Road Traffic Act (Northern Ireland) 1970(a) and now vested in it(b) and of all other powers enabling it in that behalf hereby makes the following Bye-laws:—

*Citation and commencement*

1. These Bye-laws may be cited as the Off-Street Parking (Amendment) (No. 5) Bye-laws (Northern Ireland) 1978 and shall come into operation on 13th November 1978.

*Bye-laws amended*

2. The Off-Street Parking Bye-laws (Northern Ireland) 1976(c) shall be amended as follows:—

- (a) by the substitution for item 43 Part I Schedule 1 of the provisions in Schedule 1; and
- (b) by the addition to Schedule 1 Part I of the car parks included in Schedule 2.
